II. TERMS OF APPLICATION

(1) *All deliberations of the membership committee and the Board concerning this application for memberships are and shall remain confidential to the committee and the Board.*

(2) *Applicant agrees that it has received and read the Bylaws and Rules and Regulations of the Club and understands the provisions of both the Bylaws and the Rules and Regulations. If accepted for membership, the undersigned agrees to be bound by and governed by all of the terms and conditions contained in Club Bylaws, Rules and Regulations and Policies as they presently exist or are hereafter revised, modified or amended.*

(3) *Applicant understands that memberships shall be held in the name of one individual only and that access to the facilities, specifically the golf course, by the member's spouse and family will be subject to restrictions as determined by the Board of Directors from time to time.*

(4) *Applicant understands that Membership Fees and Dues may be changed without notice to applicant prior to admission to membership.*

(5) *Applicant acknowledges that the statements made in this application, including any attachment thereto, are true and correct and that the Club has relied on them considering the applicant's Membership. The applicant further agrees that if at any time in the future, the Club determines that any of the statements are untrue or incorrect, that the applicant is subject to suspension, expulsion or disciplinary action, accordance with Club Bylaws.*

(6) *The Applicant acknowledges and agrees that the Board, in its sole and absolute discretion, may grant an Applicant membership in the Club and may decline this application for any reason or no reason at all and if declined, the Club shall have no obligation to inform Applicant of any facts or reasons for its declining the Application for membership.*

(7) *Applicant hereby authorizes the Club to obtain credit and background check information for the purpose of verifying all appropriate information such as may be requested by the Club and Applicant hereby authorizes the disclosure and release of information to Club for the purpose of investigating Applicant's character, general reputation, personal characteristics, mode of living, reputation, and financial condition. Applicant hereby waives and releases Club, and each of its past, present and future members, officers, directors, agents, and employees, from any and all known or unknown claims or causes of action which Applicant, or Applicant's spouse and family, now has or may have arising from this application for membership, the process of reviewing, considering, and accepting or rejecting such application, and the obtaining or providing of information regarding the Applicant or Applicant's spouse and family. Applicant waives any right to disclosure of any information obtained by Club in evaluating this application. At the conclusion of applicant's membership application process, applicant authorizes the Club to shred, destroy or otherwise dispose of any and all documents and writings associated with the Membership application.*

(8) *Applicant agrees to pay the membership fee in full upon completion of the application process and acceptance by Club. As a Member, he/she agrees to pay all monthly dues and other charges incurred by Member, any member of Member's family and all guests or Member. Member acknowledges that assessments may occur from time to time. In the event of any action to collect delinquent sums or related to any breach of the terms of membership or the Bylaws or Rules and Regulations, applicant shall pay all sums due in accordance with Club Bylaws.*

(9) Applicant agrees that if any dispute or controversy should arise with connection with applicant's member status, or by reason of this application or relating to this application and/or applicant's subsequent membership or is related to any breach of any covenant, condition, obligation, agreement or provisions contained in or arising out of the Club Bylaws or Rules and Regulations, in that event applicant agrees to submit the dispute or controversy to binding arbitration in accordance with the arbitration provisions contained within the Club Bylaws.

(10) Applicant/Member agrees to defend, indemnify, and hold harmless, its officers, directors, agents and employees from any liability of any nature by reason or damage or injury to any person or property resulting from any acts or omissions of the undersigned, his/her family and guests or other members, their families and guests.

(11) Applicant agrees and acknowledges that if a club extends an offer of Membership to the applicant, and the applicant accepts such offer and thereafter becomes a member of the Club, that the applicant shall thereafter be bound by not only Club Bylaws and all amendments thereafter made to these Bylaws, but there is also created between the applicant and the Club, a valid and binding contract between them that requires, among other things that the Member to be responsible for and pay all dues, assessments, fees, obligations and other charges levied by the Club pursuant to the Club Bylaws.
